Letter to Customers

Dear Valued Customer,

Firstly, thank you for being one of Skipper Transport Parts most important customers.

Further to communications sent on 4th June 2021 and 5th July 2021 regarding the sale and purchase of Skipper Transport Parts being acquired by Heatley Sales Pty Ltd (Heatleys Sales) a subsidiary company of ASX listed Stealth Global Holdings Ltd, we are writing to you to advise that the planned ownership changeover date of 1st August 2021 will be extended by 2 weeks. The new date of changeover will be 15th August 2021.

We apologise if this causes any inconvenience. Like any changeover, it is imperative we deliver a seamless transition minimising any risk of disruption to the sales and services we provide to our customers. We continue to migrate systems across all locations and onboarding customers and suppliers with the aim is to preserve and protect the existing services that Skippers already provides you.

What will change:

- The legal entity under which Skipper Transport Parts trades changes from Shemapel 2005 Pty Ltd to Heatley Sales Pty Ltd (but continues to trade as Skipper Transport Parts).
- Consequently, ABN will change to that of Heatley Sales Pty Ltd.
- Address, Locked Bag and Facsimile details will change to the Heatleys Distribution Centre in Canning Vale.

What do Customers need to do?

Our team have established a trading account for your company within the Heatleys system that reflects all current arrangements you have in place with Shemapel 2005 Pty Ltd. Our team continue to contact customers to ensure they please create a new supplier account in their accounts system to reflect these changes to Heatleys.

Invoice and payment responsibility

Up to and including Saturday 14 August 2021, you will continue to receive invoices from Shemapel 2005 Pty Ltd trading as Skipper Transport Parts. These invoices are to be processed under your current Skipper Transport Parts supplier account and the bank details for payment of those invoices remain unchanged.


From Sunday 15 August 2021 onwards, you will receive invoices from Heatley Sales Pty Ltd trading as Skipper Transport Parts. These invoices are to be processed under the newly created supplier account which reflect the new ABN and bank details.
